The run will start from Station Road Car Park, Sheringham NR26 8RE with the lineup starting from 8.30am with the first vehicles being waved away at around 9.30 am. Don't forget to fly your flag of St George!

There will be two routes going through the North Norfolk countryside which will finish at The Royal Estate Sandringham via The West Newton Gate PE31 6AZ. Dogs are allowed but **MUST** be kept on a lead at ALL times. Light refreshments including bacon butties will be available at the start, there will be various refreshment options at Sandringham including a limited number of a pre bookable and pre paid 2 course Sunday Roast Lunch with tea or coffee to be served between 12.15 and 2.45pm in a reserved area @ £18 per head. Please indicate on the Entry Form if you wish to receive a booking form for lunch.

Hot and cold meals and snacks will also be available in the Visitor Centre or Stables Tearoom in the normal way.

There will be a grand raffle in aid of EAAA to be drawn at the finish.

A special price of £10 per person for entrance to Sandringham House, Gardens and Museum OR £7 per person for Gardens and Museum only will be available upon production of voucher which will be contained in your route book.

**To enter the run we request a MINIMUM donation of £10 to the East Anglian Air Ambulance payable in advance with your entry. This will include a souvenir photograph taken on your arrival at Sandringham.**
