**Incident:** Driver passed chequer flag twice ( note a repeater was in use ) Interviewed driver who admitted this . However as mitigation he confirmed he had seen the chequer and slowed down but on approach to pit entry another car went off in front of him ( 49 also interviewed ) and he was unable to enter pit lane safely
