Car 74 went up the inside of car 31 from a long way back (car 31 was on the racing line), collided with car 31 and forced both cars off the track.			
Circuit & in-car video from car 74 viewed. Driver of car 74 admitted complete fault in the incident and that he outbraked himself thus causing the accident.			
Driver of car 74 was very apologetic and remorseful. He had already apologised to the driver of car 31 before coming up to race control.
